## Application form for Small Business Rate Relief from 1 April 2018

The Small Business Rate Relief Scheme provides a maximum of 100% mandatory rate relief for properties with a rateable value up to £12,000, with relief declining on a sliding scale until – at a rateable value of £15,000 – there is no entitlement to relief.

Relief is only available to:

- Businesses occupying one property in England, with a rateable value less than £15,000, or
- Businesses with one main property and other additional properties in England, providing the additional properties have individual rateable values below £2,900 and the combined rateable value of all the properties is below £20,000, as shown in the local non-domestic rating list for that day. In such cases relief will only be applied on your main property (i.e. the property with the highest rateable value).
- Businesses which are not already in receipt of Charitable, Community Amateur Sports Club, Discretionary or Rural Rate Relief.

In addition to this relief on liability, eligible businesses with rateable values of between £18,000 & £51,000 have their liability calculated using the current small business multiplier.

Complete the form overleaf and return it to the Business Rates Team at the address provided. Applications will normally only be accepted during the current financial year, and up to six months after it has ended.

Please note that notification of your entitlement will be shown either on your annual bill in March, or on an adjustment bill during the year if your application is processed after that time.
