THE HERTSMERE BOROUGH COUNCIL (ST PETERS CLOSE, HIGH ROAD, BUSHEY HEATH) (CONTROLLED PARKING ZONE) (PARKING PLACES) (AMENDMENT NO.2) ORDER 2014

Hertsmere Borough Council (hereinafter referred to as “the Council”) pursuant to arrangements made with Hertfordshire County Council (“the County Council”) under Section 19 of the Local Government Act 2000 and the Local Government (Arrangements for Discharge of Functions) (England) Regulations 2000 in exercise of the powers on the said County Council by Sections 1, 2, 3, 4, 32, 33, 45, 46, 49 and 53 to the Road Traffic Regulation Act 1984 (hereinafter referred to as “the Act of 1984”), Part IV of Schedule 9 of the Act of 1984, Regulation 21 of the Local Authorities Traffic Orders (Procedure) (England and Wales) Regulations 1996 and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby make the following Order:

Commencement and Citation

1. This Order shall come into operation on 1 May 2014 and may be cited as The Hertsmere Borough Council (St Peters Close, High Road, Bushey Heath)(Controlled Parking Zone) (Parking Places) (Amendment No.2) Order 2014 hereinafter referred to as “this Order”.
2. Schedule 1 of the The Hertsmere Borough Council (St Peters Close, High Road, Bushey Heath)(Controlled Parking Zone) (Parking Places) Order 2014 shall be revoked and replaced by Schedule 1 of this Order.
3. Schedule 2 of the The Hertsmere Borough Council (St Peters Close, High Road, Bushey Heath)(Controlled Parking Zone) (Parking Places) Order 2014 shall be revoked and replaced by Schedule 2 of this Order.
4. The Hertsmere Borough Council (St Peters Close, High Road, Bushey Heath)(Controlled Parking Zone) (Parking Places) (Amendment No.1) Order 2014 shall be revoked in its entirety

SCHEDULE 2.

High Road, Bushey Heath – Places for Resident and Resident visitor parking only Mon-Sat, 8.30am-6.30pm

High Road (west side)	1. From a point approximately 2 metres south east of the north west boundary of property number 11 High Road, south eastwards for a distance of approximately 14 metres.
High Road (east side)	2. From a point approximately 2 metres south east of a point on the line of the common boundary between property numbers 20 and 22 High Road north westwards for a distance of approximately 5 metres
High Road (east side)	3. From a point approximately 3 metres south east of a point on the line of the common boundary between property numbers 22 and 24 High Road south eastwards for a distance of approximately 5 metres
High Road (east side)	4. From a point in line with the common boundary between property numbers 28 and 30 High Road south eastwards for a distance of approximately 16 metres
