LOCATION

The premises are available to let, on a new lease, subject to contract:-

TERM	A five, ten or fifteen year term is available.
RENT	£10,000 per annum exclusive of VAT and outgoings.
RENT REVIEWS	Five yearly upward only rent reviews.
USER	A1 use (or A2 permitted subject to appropriate planning consent). (Café or takeaway use ie A5 will not be permitted).
REPAIRS	The tenant is responsible for the repair and maintenance of the interior of the shop, for the shopfront, windows and all doors.
OUTGOINGS	The tenant will pay all outgoings connected with the shop, including business rates, building insurance and all utility charges.
INSURANCE	The tenant will reimburse the Council the cost of building insurance for this shop under the Council's block policy. In 2016/17 this amounts to £67.17. (Can vary from year to year).
ALIENATION	Assignment of the whole of the premises, only with the Council's prior written consent, subletting is prohibited.
RATEABLE VALUE	£6,000. The business rates payable are £2,796 (2017/2018) based on a UBR of 46.6p, you may be able to also claim full Business Rates Relief and therefore pay less business rates.
