### **Annex 1 - Mandatory conditions.**

Where a programme includes a film in the 12A, 15 or 18 category of the British Board of Film Classification, no person appearing to be under the age of 12 (and unaccompanied in that case), 15 or 18 as appropriate shall be admitted to any part of the programme; and the licence holder shall display in a conspicuous position a notice in the following terms: -

*Persons under the age of (insert appropriate age) cannot be admitted to any part of the programme.*

Where films of different categories form part of the same programme, the notice shall refer to the oldest age restriction. This condition does not apply to members of staff under the relevant age while on duty provided that the prior written consent of the person's parents or legal guardian has first been obtained.

### **Annex 2 - Conditions consistent with the operating schedule.**

1. This premises licence shall extend to the school theatre building only.
2. Admission to licensed activities ("performances") shall be limited to persons who have been issued with tickets prior to the date of their performance.
3. CCTV systems shall be maintained in full working order.
4. The parking areas and access footpaths to the theatre shall be maintained in a safe condition and adequately illuminated.
5. Noise or vibration shall not be permitted to emanate from premises so as to cause a nuisance to nearby properties. The audience shall be requested to leave the premises quietly at the end of performances.
6. Children shall be supervised by school staff with enhanced Criminal Records Bureau clearance. All school staff shall receive child protection training.
