#### **Annex 1 - Mandatory conditions.**

No supply of alcohol may be made under this licence

1. At a time when there is no designated premises supervisor in respect of it or,
2. At a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended

Every retail sale or supply of alcohol made under this licence must be made or authorised by a person who holds a personal licence.

#### **Mandatory licence condition imposed by The Licensing Act 2003 (Mandatory Licensing Conditions) Order 2010**

(1) The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol.

(2) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.

**Annex 2 - Conditions consistent with the operating schedule.**

The shop's outside security grills must be maintained and used at night when the premises are closed.

The first aid kit and fire fighting equipment must be maintained and in full working order.
