No supply of alcohol may be made under this licence

1. At a time when there is no designated premises supervisor in respect of it or,
2. At a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.

Every retail sale or supply of alcohol made under this licence must be made or authorised by a person who holds a personal licence.

All embedded restrictions and conditions inherent in the Licensing Act 1964.

Annex 2 Conditions consistent with the operating schedule.

There will be (at least) one Personal Licence holder on site.

Provision of iced water and a range of soft drinks to be available.

On all managers and staff must receive training on understand the licensing law.

CCTV and Fire Extinguishers must be maintained and in full working order.

An emergency lighting system must be in place

The recording of fire drills, alarm and emergency lighting testing is kept on site.

There shall be good access for disabled customers.

Floor Staff to conduct physical sweeps inside the premises to remove hazardous objects/waste.

Telephone number of an allocated taxi firm displayed on the premises.

Prominent, clear and legible notices are to be displayed at all exits requesting patrons to respect the needs of local residents and to leave the premises and the area quietly.

Emergency call procedures must be in place.

Any children under 16 years remain the responsibility of the accompanying adult when using the premises.

No adult entertainment (paid for by the company of a nude physical nature) is permitted at these premises.

To persons thought to be under the age of 18, I.D must be required and if not provided or in any doubt of the I.D then the service of alcohol must be refused.

The Premise keeps adopting the code of practice operated by the Portman Group and only accepts proof of age cards carrying the PASS logo.
