- 1. At a time when there is no designated premises supervisor in respect of it or,
- 2. At a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended

Every retail sale or supply of alcohol made under this licence must be made or authorised by a person who holds a personal licence.

## Annex 2 - Conditions consistent with the operating schedule.

- 1. CCTV and security alarms shall be maintained and be in full working order.
- 2. Security shutters and locks to the premises shall be maintained and kept in a good state of repair.
- 3. Illuminated exit signage shall be provided above fire exits. Emergency lighting shall be provided so as to ensure appropriate escape lighting for members of the public.
- 4. Fire Extinguishers shall be maintained and be in full working order.
- 5. Customers attempting to purchase alcohol, who appear to be under 21 are required to produce I.D. including their date of birth and a photograph. The "challenge 21" shall be implemented.
- 6. On or before commencing employment all managers and staff shall receive training and are required to understand licensing law. They are also required to undertake an in store refresher course with records of training held at the premises.
- 7. A log of alcohol sale refusals shall be kept on the premises at all times and be made available for inspection by a Police or Licensing Officer if required.
- 8. Alcohol shall only be placed on the shop floor or shelving where it is clearly visible from the shop counter.
- 9. Packaging waste and other refuse shall be stored and disposed of appropriately so as not to cause a nuisance.
