Annex 1 - Mandatory conditions.

No supply of alcohol may be made under this licence

1. At a time when there is no designated premises supervisor in respect of it or,
2. At a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended

Every retail sale or supply of alcohol made under this licence must be made or authorised by a person who holds a personal licence.

Intoxicating liquor shall not be sold or supplied on the premises otherwise than to persons taking table meals there and for consumption by such a person as an ancillary to his meal.

Suitable beverages other than intoxicating liquor – including drinking water – shall be equally available for consumption with or otherwise ancillary to meals in the licensed premises.

Annex 2 - Conditions consistent with the operating schedule.

- All electrical equipment and electrical circuits at the premises are to be regularly checked by a qualified electrician and any remedial work considered necessary as a result of such inspection must be carried out promptly.
- Adequate fire fighting equipment must be available and maintained in good working order. Staff will be given adequate training as to the operation of such equipment.
- Proper steps must be taken to ensure that the numbers of persons using the premises at any time are within safe capacities.
- A comprehensive risk assessment will be carried out by the applicant in respect of the premises and any necessary measures in addition to the above will be put in place.

- Glass waste must not be disposed of between 21:00 and 09:00 the following day.
- All substantial deliveries to the premises must be made during daylight hours.
- No children as defined in the Licensing Act 2003 are to be allowed on the premises unless accompanied by a responsible adult.
- No gambling is to be allowed on the premises, at any time.
