**Annex 2 - Conditions consistent with the operating schedule.**

Not to allow the use or supply of illegal drugs on or in the vicinity of the premise, if such activity is suspected staff are to inform the police immediately.

Glassware is not to be used or supplied.

Premise to comply with all relevant legislation.

Staff to deter customers from congregating on the premises.

Doors and windows to be kept closed at night to prevent the transmission of noise.

Staff are to ask customers to leave the premises quietly.

Drivers are to enter and leave their vehicles quietly, to park considerately and not leave the engines running.

All equipment must be properly sound insulated and maintained in good working order.

The air extractor system to be kept and maintained in good working order to prevent smells from entering neighbouring premises.

### **Annex 3 - Conditions attached after hearing by the licensing authority.**

CCTV is fitted to cover both the inside and the front and rear areas immediately outside the premises. The tapes and images captured from the CCTV shall be retained for a period of not less than 30 days and shall be made available to the Police on request as necessary. Notices advising people that CCTV is in operation shall be displayed on the premises.

The pavement area outside of the shop to be cleaned upon closure at night.

Temporary litterbins. be placed outside whilst the premises are open.

Prominent, clear and legible notices are to be displayed at all exits requesting patrons to respect the needs of local residents and to leave the premises and the area quietly.

Prominent, clear and legible notices are to be displayed at the rear exit requesting delivery drivers to enter and leave vehicles quietly, not to leave engines running, to park considerately and at all times to respect the needs of local residents.

All delivery vehicles stored at the premises shall be returned to the rear of the premises at the close of business and shall be returned without the use of their engines.

All delivery vehicles to be clearly identified with company logos.

A contact telephone number will be manned and made available to the public while the premises are open.

All deliveries shall be made through the front door only after 21.00 hours.
