Annex 1 - Mandatory conditions.

No supply of alcohol may be made under this licence

1. At a time when there is no designated premises supervisor in respect of it or,
2. At a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended

Every retail sale or supply of alcohol made under this licence must be made or authorised by a person who holds a personal licence.

Annex 2 - Conditions consistent with the operating schedule.

The premises licence holder shall ensure that:-

The Prevention of crime and disorder

1. The supply of alcohol is restricted to the areas identified on the plan attached to the application;
2. Any person selling or supplying alcoholic drink under the authority of a personal licence holder asks for a photo ID proof of age where they have reason to suspect that the individual may be under 18 years of age;
3. The maximum occupancy of the licensed premises is restricted at any one time to 15;
4. Public information notices about crime and disorder issues are displayed at the request of the local authority or police;
5. Lighting is provided outside the premises during the hours of darkness when any licensable activity takes place on the premises;

Public Safety

6. Escape routes and exits are maintained to ensure that they are not obstructed, in good order and not slippy, free of trip hazards and clearly identified;
7. All exit doors are easily openable and do not require the use of a key, card, code or similar means whilst the premises are open to the public for the licensed activities;
8. Temporary decorations are not used without prior notification to the local authority and fire authority;
9. The fire brigade shall be called at once to any outbreak of fire and the details recorded in a Fire Log-book;
10. The local fire control centre is notified as soon as possible if the water supply to any hydrant, hose reel, sprinkler, drencher or other fire extinguishing installation within the premises is cut off or restricted;
11. That when disabled people are present, adequate arrangements exist to enable their safe evacuation in the event of an emergency;
12. In the absence of adequate daylight, that the lighting in any area accessible to the public is fully operational;
13. There is valid public liability insurance in force and that a copy of the schedule is available for inspection by an authorised officer on request;
14. The premises are not altered in such a way as to make it impossible to comply with an existing licence condition, without first seeking a variation of the premises licence;
15. There is a "hot-line" provided to a local taxi firm;
16. Portable heating appliances are not used on the premises;

The Prevention of Public Nuisance

17. Doors and windows are kept closed to reduce noise nuisance from the premises;
18. Prominent, clear and legible notices are displayed requesting customers to respect the needs of local residents and to leave the premises quietly during late hours;
19. Any request by an authorised officer of the local authority in relation to reducing noise levels is complied with;
20. Offensive smells from the licensed premises are not permitted so as to cause a nuisance to nearby properties and the premises are properly vented;
21. Receptacles for waste are emptied regularly to minimise nuisance smells;
22. Litter is regularly cleared from the close vicinity of the premises;

The Protection of Children from Harm

23. Children under the age of 12 present at the premises are accompanied by adults after 23:00 hours.
