Annex 1 - Mandatory conditions.

No supply of alcohol may be made under this licence

1. At a time when there is no designated premises supervisor in respect of it or,
2. At a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended

Every retail sale or supply of alcohol made under this licence must be made or authorised by a person who holds a personal licence.

Annex 2 - Conditions consistent with the operating schedule.

All staff must be appropriate in respect of relevant licensing law including general health and safety.

CCTV must be installed and working to the satisfaction of the Police and Licensing Authority.

CCTV recordings will be maintained for 31 days on a digital video recorder.

An alarm system must be installed with panic buttons and must be adequately maintained.

All fire doors must be effectively self-closing and must not be held open.

All fire exits and means of escape will be signed in accordance with BS5499

Fire Safety signs must be adequately illuminated.

Emergency lighting must be installed and regularly maintained.

The premise must have portable fire fighting equipment, which is fully maintained.

A suitable evacuation plan in case of emergency must be in operation in the premises.

Deliveries must be conducted during the daytime to control noise nuisance.

Between the hours of 17:00 and 23:00 a minimum of two persons must be working at the premises.

The premises must have clear signs explaining the reasons for restrictions of sales of alcohol to persons under 18 and to the sales of tobacco products to persons under 16.

The premises must operate a Proof of Age policy and must only accept a Passport, New Photo Driving Licence Card, Portman Group ID or a card with the PASS logo. If a person is not able to produce this as suitable proof of age then sales must be refused.

A refusal log must be kept on the premises.

No person must be allowed to hang – around outside the shop premises.

No one will be allowed to consume alcohol outside the shop premises (a polite request must be made to any such person)
