1. Prominent, clear and legible notices are to be displayed at all exits and in the car park requesting patrons to respect the needs of local residents and to leave the premises and the area quietly.
2. The pavement area immediately outside the premises is to be cleaned upon closure at night.

3. A metal litter bin is to be provided outside the premises during the hours when the premises are open and remove when they are closed, and emptied regularly.
4. The tapes and images captured from the internal CCTV shall be retained for a period of not less than 30 days and shall be made available to the Police on request.
