#### **Annex 1 - Mandatory conditions.**

No supply of alcohol may be made under this licence

1. At a time when there is no designated premises supervisor in respect of it or,
2. At a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended

Every retail sale or supply of alcohol made under this licence must be made or authorised by a person who holds a personal licence.

Where a programme includes a film in the 12A, 15 or 18 Category of the British Board of Film Classification, no person appearing to be under the age of 12 (and unaccompanied in that case), 15 or 18 as appropriate shall be admitted to any part of the programme; and the licence holder shall display in a conspicuous position a notice in the following terms:-

*Persons under the age of (insert appropriate age) cannot be admitted to any part of the programme.*

Where films of different categories form part of the same programme, the notice shall refer to the oldest age restriction. This condition does not apply to members of staff under the relevant age while on duty provided that the prior written consent of the person's parents or legal guardian has first been obtained.

All electrical installations shall be inspected once a year by a competent electrical engineer appointed by or on behalf of the licensee of the premises and a certificate stating the conditions of the installation shall after each inspection be forwarded to the licensing authority by or on behalf of the occupier of the premises.

No standing shall be allowed in any auditorium during a film showing.

Notwithstanding Regulation 14 of the Council's Cinematographic Conditions 1982, the premises shall be allowed to remain open until 02:30 the following mornings on Fridays and Saturdays and to open at 10:00 including Sundays.

If the licensing authority do not agree with the category in which any film is passed by the British Board of Film Classification is placed, they shall be liberty to alter such category, and, on notice of such alteration being given by the licensing authority to the licensee, the film thereafter shall be treated as having been placed in the altered category and the conditions applicable to the exhibition of films in such altered category shall be complied with.

If the licensing authority requests the licensee to exhibit to them any film, he shall do so at such reasonable time as the licensing authority may, in writing, direct.

**Annex 2 - Conditions consistent with the operating schedule.**

1. CCTV shall be installed and monitored at the premises.
2. Alcohol and late night refreshments may only be sold to customers who hold a valid ticket to watch a film at the premises.
3. No sale of alcohol shall be made to any customer who appears to be intoxicated.
4. The premises licence holder shall ensure that all staff are fully trained to check the age of any customer buying alcohol at the premises and also ensure that they are instructed not to sell alcohol to anyone who appears to be intoxicated.
5. The premises licence holder shall ensure that tickets are checked and that screens are patrolled.
6. Recorded music may only be played at volume levels that are not audible outside the premises.
7. The premises licence holder shall implement a "Challenge 25 Scheme" and ensure that anyone who appears to be under the age of 25 provides proof of their age when buying alcohol or a ticket for a film.
