## **Annex 2 - Conditions consistent with the operating schedule.**

1. A CCTV system shall be maintained to monitor the inside and the immediate vicinity outside the premises. Recordings shall be kept for at least 31 days, stamped with the time and date and be made available to the local authority and police within 24 hours of any request.
2. The premises licence holder shall keep records of persons committing public nuisance and discourage such behaviour by reporting it to the appropriate authorities.
3. Service shall be declined to persons who are or appear to be drunk.
4. One litterbin shall be maintained inside and another outside the premises. Litter shall be cleared from the pavement for a distance of at least 100 metres either side of the entrance to the premises.

## **Annex 3 - Conditions attached after hearing by the licensing authority.**

1. Prominent, clear and legible notices shall be displayed at all exits requesting patrons to respect the needs of local residents and to leave the premises and the area quietly.
2. The hours of business shall be displayed in a prominent and clear location on the premises.
