### **Annex 1 - Mandatory conditions.**

No supply of alcohol may be made under this licence

1. At a time when there is no designated premises supervisor in respect of it or,
2. At a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended

Every retail sale or supply of alcohol made under this licence must be made or authorised by a person who holds a personal licence.

### **Annex 2 - Conditions consistent with the operating schedule.**

1. Alcohol shall be supplied only to members of the club, their guests, persons using the golfing facilities and persons attending any function at the premises previously booked by a member.
2. Only children who are members of or guests of members of the club shall be admitted to the premises.
3. In relation to persons thought to be under the age of 18, I.D. must be required and if not provided or if there is any doubt about the I.D. then the service of alcohol must be refused.
4. Fire exits shall be kept clear of any obstruction. Illuminated exit signage shall be provided above fire exits.
5. Fire extinguishers shall be maintained and be in full working order.
6. Smoking is prohibited on the entire premises.
