Annex 1 - Mandatory conditions.

1. Any person exercising a security activity (as defined by paragraph 2(1)(a) of schedule 2 of the Private Security Industry Act 2001) shall be licensed by the Security Industry Authority.

Annex 2 - Conditions consistent with the operating schedule.

1. The premises licence holder shall not permit food and drink to be consumed on the premises.
2. Drink shall not be served in glass bottles.

Annex 3 - Conditions attached after hearing by the licensing authority.

1. The provision of night refreshment may take place between:

Sunday to Thursday from 23.00 until 01.30 hours
Friday and Saturday from 23.00 until 02.00 hours.

2. CCTV shall be fitted to cover both the inside and area immediately outside the premises. Images shall be stored for a minimum of thirty days with access to them made available to the police and licensing authority staff in that period.

3. The pavement area outside the shop shall be cleaned upon closure at night.

4. Temporary litterbins shall be placed outside whilst the premises are open.

5. Prominent, clear and legible notices shall be displayed at all exits requesting patrons to respect the needs of local residents and to leave the premises and the area quietly.

6. A minimum of one registered Door Supervisor shall be on the premises from 23.00 hours until closing.
