A= Plays, **B**= Films, **C**= Indoor sporting Events, **D**= Boxing or Wrestling entertainments, **E**= Live music, **F**= Recorded music, **G**= Performance of dance, **H**= Anything of a similar description to that falling within (E), (F) or (G), **I**= Late night refreshment, **J**= Supply of alcohol, **K**= Adult entertainment. **L** denotes the hours during which the premises are open to the public.

(In relation to an application for a Club Premises Certificate: **I**= Supply of Alcohol. **J** denotes the hours during which the club premises are open to its members and guests.)
