| Licence Fee - | Offers are invited for this Licence (fee guide price £2,000 p.a.). Offers should be made in writing to the Senior Estates Surveyor, Hertsmere Borough Council, Civic Offices, Elstree Way, Borehamwood, WD6 1WA and must be received by 12 noon Friday 15 April 2016. The Council will be under no obligation to accept the highest or any offer. The Licence fee is to be paid quarterly in advance by 4 equal payments. The Licensee will be required to pay a contribution of £500 towards the Council's costs in preparing the Licence. |
| User - | The grazing of horses or cattle will be permitted. In the case of horses, no more than seven will be permitted to graze on the land at any one time. The land is not to be used for livery. |
| Repairs - | The Grazier will be responsible for maintaining the land and all fences, hedges and gates in a good and stockproof condition. |
| Improvements - | No buildings will be permitted to be erected on the land other than a timber shelter that has one open side (subject to planning and any other statutory consents). |
| Assignment - | The Licence will be personal to the Grazier who shall not in any way assign it to or share it with another party. |
| Outgoings - | The Grazier will pay all outgoing which occur through his/her use of the land. |
| Termination - | The Licence may be terminated by the Grazier or the Council on the service of one months' notice in writing. |
