

WILDLIFE AND COUNTRYSIDE ACT 1981

The Definitive Map and Statement of Public Rights of Way in Hertfordshire

Hertfordshire County Council (Aldenham 95 & 96 and Elstree & Borehamwood 64 & 65) Modification Order 2017

This Order is made by Hertfordshire County Council under Section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to the Secretary of State that the Definitive Map and Statement of Public Rights of Way in Hertfordshire require modification in consequence of the occurrence of an event specified in Section 53(3)(c)(i) and (iii) of the Act, namely

(c) the discovery by the authority of evidence which (when considered with all other relevant evidence available to them) shows

(i) that a right of way which is not shown in the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates, being a right of way such that the land over which the right subsists is a public path, a restricted byway or, subject to section 54A, a byway open to all traffic, and

(iii) that there is no public right of way over land shown in the map and statement as a highway of any description, or any other particulars contained in the map and statement require modification.

The authority has consulted with every local authority whose area includes the land to which the Order relates. Hertfordshire County Council hereby order that:

1. For the purposes of this Order the relevant date is 11th August 2017.
2. The Definitive Map and Statement of Public Rights of Way in Hertfordshire shall be modified as described in Part I and Part II of the Schedule and shown on the plan attached to the Order ("the Order Plan").
3. This Order shall take effect on the date it is confirmed and may be cited as the Hertfordshire County Council (Aldenham 95 & 96 and Elstree & Borehamwood 64 & 65) Modification Order 2017.

**SCHEDULE
PART I
Modification of Definitive Map**

DESCRIPTION OF PATH OR WAY TO BE ADDED

A public footpath commencing from the junction between Aldenham footpath 52 and Elstree & Borehamwood footpath 1 on the parish boundary at TQ 1669 9585 (point A on the Order Plan) running in a generally south westerly direction across the grass between the car park and the north west side of Aldenham Reservoir for approximately 170 metres to the edge of the woodland at TQ 1659 9572 (point B on the Order Plan). Continuing in a generally southerly then easterly direction within the woodland, past the children's play area, for approximately 290 metres to TQ 1679 9557 (point C on the Order Plan). Continuing in a southerly direction on the west side of Aldenham Reservoir for approximately 170 metres to TQ 1676 9540 (point D on the Order Plan) and then in a generally west and north westerly direction for approximately 180 metres to TQ 1660 9546 (point E on the Order Plan). Continuing in a generally north west then south west direction adjacent to paddocks at Aldenham Country Park for approximately 140 metres to TQ 1652 9540 (point F on the Order Plan). Continuing in a south and south easterly direction for approximately 250 metres to cross the bridge at TQ 1672 9530 (point G on the Order Plan) and continuing in a generally south easterly then southerly direction for approximately 200 metres to TQ 1679 9514 (point H on the Order Plan) then in a generally east north easterly direction on the south side of Aldenham Reservoir, parallel to A411 Watford Road for approximately 430 metres to a junction with Elstree & Borehamwood footpath 5 at TQ 1716 9525 (point I on the Order Plan).

Width:

- 7 metres between TQ 1669 9585 (point A on the Order Plan) and TQ 1659 9572 (point B on the Order Plan), narrowing to
- 3 metres between TQ 1659 9572 (point B on the Order Plan) and TQ 1676 9540 (point D on the Order Plan) and between TQ 1672 9530 (point G on the Order Plan) and TQ 1679 9514 (point H on the Order Plan) subject to mature trees, narrowing to
- 2.5 metres between TQ 1676 9540 (point D on the Order Plan) and TQ 1660 9546 (point E on the Order Plan) and between TQ 1679 9514 (point H on the Order Plan) and TQ 1716 9525 (point I on the Order Plan) subject to mature trees,
- varying between 2.4 metres and 6 metres between TQ 1660 9546 (point E on the Order Plan) and TQ 1652 9540 (point F on the Order Plan) as shown shaded grey on the Inset on the Order Plan,
- 3.5 metres between TQ 1652 9540 (point F on the Order Plan) and TQ 1672 9530 (point G on the Order Plan) subject to mature trees.

Commences from junction with Aldenham 52 and Elstree & Borehamwood 1 on parish boundary at TQ 1669 9585 running SW across the grass between the car park and the NW side of Aldenham Reservoir for approx. 170m to the edge of the woodland at TQ 1659 9572 and a junction with Elstree & Borehamwood 64.

Commences from a junction with Aldenham 95 at TQ 1659 9572 running S and E within the woodland, for approx. 290m to TQ 1679 9557. Then S on the W side of Aldenham Reservoir for approx. 170m to TQ 1676 9540 and W and NW for approx. 180m to TQ 1660 9546 and a junction with Aldenham 96.

Width Subject to mature trees,
3 metres between TQ 1659 9572 and TQ 1676 9540, narrowing to
2.5 metres between TQ 1676 9540 and TQ 1660 9546

Width Subject to mature trees,
3.5m between TQ 1652 9540 and TQ 1672 9530, narrowing to
3m between TQ 1672 9530 and TQ 1679 9514, narrowing to
2.5m between TQ 1679 9514 and TQ 1716 9525

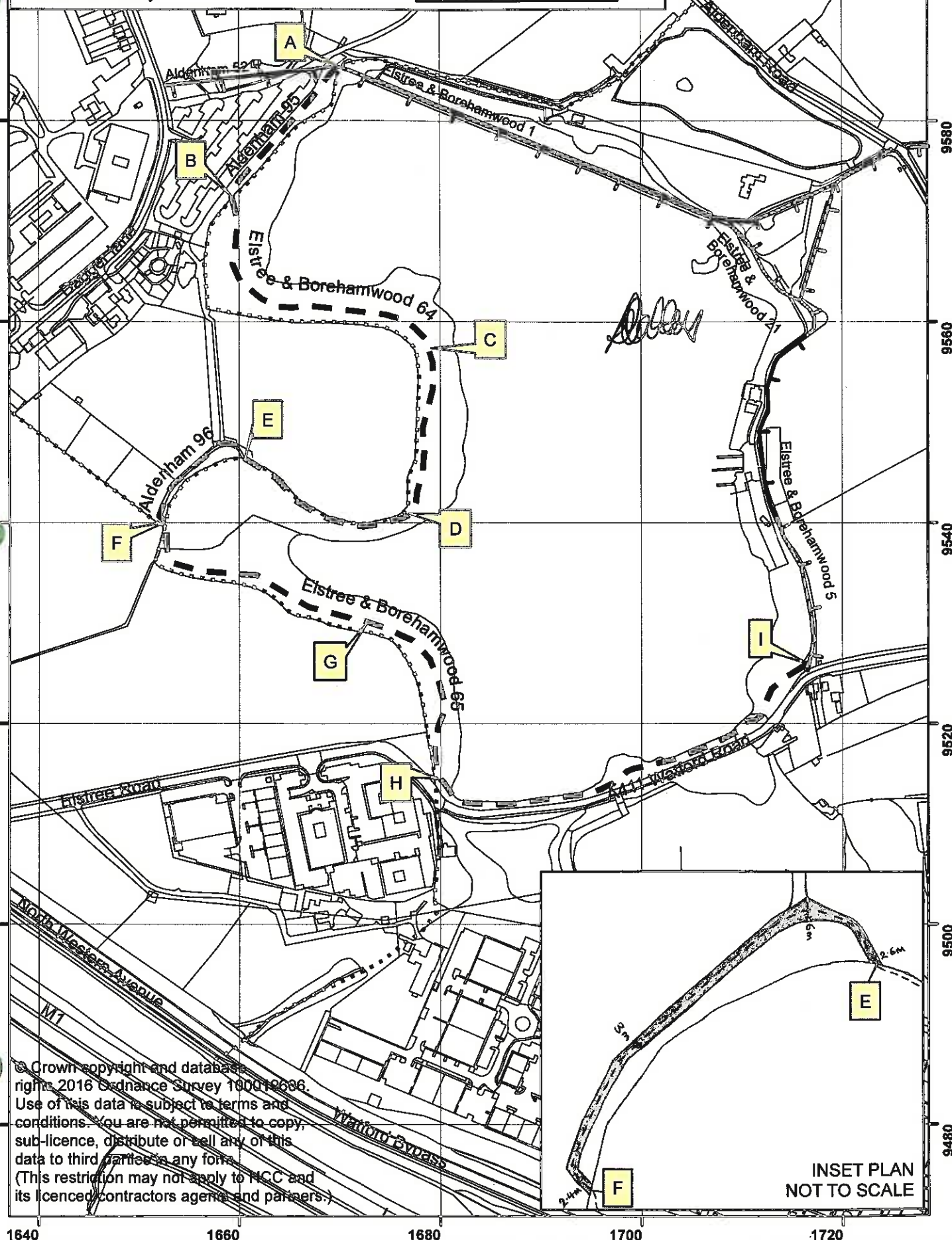

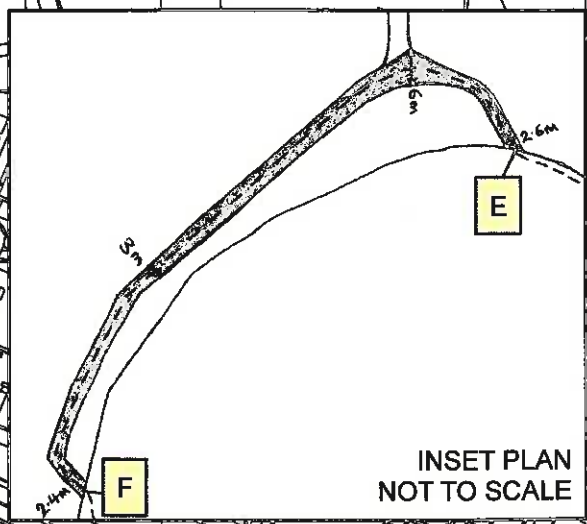
Parish Boundary
