Dear Sirs,

I am writing to express my comments regarding the Elstree Corridor Proposals.

- 1. Is the residential elements going to be built to Lifetime home Standards, the Code for Sustainable Homes or the RIBA Homewise recommendations and if not why not?
- 2. Given the precedent of recent new housing developments in Borehamwood does the Council agree that the minimum parking standards are set too low, given all the cars on such estates inevitably end up parked all down the road on the pavement? The current parking standards only require 1 parking space for a three bed property which in reality it is not beyond reason to suspect that a three bedroom property could contain a household of 6 persons each with their own car. As much as it is encouraged for people to use public transport, the reality is that most people drive and have a car, even if they commute to work by public transport during the week.
- 3. Page 15 of the Elstree Way Corridor Area Action Plan shows a revised layout of the roads in this area. The first point that I would like to make is the number of bus stops so close to one another and are also in very close proximity to a large roundabout. Is it the wisest place to position stopping points for buses directly after a roundabout? The bus stop heading towards Elstree Studios from the Maxwell Road junction will (and does) stop all the traffic as buses stop meaning that many overtake the bus which is dangerous for oncoming traffic. The other bus station in front of the studios will also cause the same problem. Is it a consideration to use the Tesco bus hub to allow people to access the bus safely and separately from the high volume of traffic in these areas as it is a very short walk from each of these stops?
- 4. Page 15 of the Elstree Way Corridor AAP also shows the access from the fire station moved from the main road to a side road to then relink to the main road. Surely this will cause an issue for the Ambulance and Fire service, the proposal impedes on there access to a main road directly which could cause a delay to their response times.
- 5. The new proposed crossings are a positive element as currently it is certainly very difficult to cross the road safely in this area, especially from Tesco towards McDonalds.
- 6. Has anyone considered using the centre of the roundabouts for anything other than grass? These are fairly large inaccessible space which go unused and only creates a maintenance plan.
- 7. Quite possibly outside of the scope of the Elstree Way Corridor document, however with all the additional house holds will the Boulevard shopping area be reconsidered. Already during peak time Theobald Street and Shenley Road become inaccessible due to the high volume of traffic going in and out of the Boulevard. A consideration would be to have an additional entrance and exit towards Furzehill Road. This would also act as a gateway to the town for people traveling into the area is many travel into Borehamwood via Furzehill Road.
- 8. I see a lot of information about housing and the number of affordable units however I do not see much information about industry and jobs. With the influx of people coming to the area is the Council confident that the current infrastructure can support and sustain this amount of people, especially if these people are not going to be commuting into London for work? If it is proposed that these people are going to be working in London has First Capital Connect been consulted, in terms of up scaling their facilities to cope?

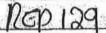

# **GUIDANCE NOTES**

#### Introduction

These guidance notes have been produced to assist anyone who wishes to make a formal representation on the published Elstree Way Corridor Area Action Plan submission document, which is subject to a period of representations from 17<sup>th</sup> February 2014 to 31<sup>st</sup> March 2014. The Area Action Plan is published in order for representations to be made prior to the submission for public examination. The representations will be considered alongside the submitted Area Action Plan, by a independent Planning Inspector.

The Planning and Compulsory Purchase Act 2004<sup>1</sup> (the 2004 Act) states that the purpose of the examination is to consider whether the Area Action Plan complies with legal requirements and is 'sound'. The representations supporting, objecting or commenting more generally should be made within this context.

#### Soundness

Soundness is explained fully in the National Planning Policy Framework<sup>2</sup>, in paragraph 182. The Inspector has to be satisfied that the Area Action Plan has been positively prepared, is justified, effective and consistent with national policy. To be sound the Area Action Plan should be:

Positively prepared — the plan should be prepared based on a strategy which seeks to meet objectively assessed development and infrastructure requirements, including unmet requirements from neighbouring authorities where it is reasonable to do so and consistent with achieving sustainable development;

Justified – the plan should be the most appropriate strategy, when considered against the reasonable alternatives, based on proportionate evidence;

Effective – the plan should be deliverable over its period and based on effective joint working on cross-boundary strategic priorities; and

Consistent with national policy – the plan should enable the delivery of sustainable development in accordance with the policies in the Framework.

- 1) If you are seeking to make representations on the way in which the Local Planning Authority (LPA) has prepared the published Area Action Plan it is likely that your comments or objections will relate to a matter of legal compliance.
- 2) If it is the actual content on which you wish to comment or object it is likely it will relate to whether the Area Action Plan is justified, effective or consistent with national policy.

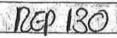
