Proposed changes to Green Spaces Policies

As a result of his consideration of the Site Allocations and Development Management (SADM) Policies Plan to date, the Inspector has requested the Council to re-consider policies SADM35 Major Green Space and SADM36 Local Green Space in the Submitted Plan; this includes reviewing the sites to which the policies apply. The Council has now undertaken this review and submitted proposed changes to policies SADM35 and SADM36 and the sites to which the policies will apply to the Inspector. These are contained within a revised Open Spaces section of the Plan. There is now an opportunity for interested people and groups to submit comments on this revised Open Spaces section prior to the Examination Hearings so that the Inspector can consider them.
