HERTSMERE BOROUGH COUNCIL (CARPENTER WAY, POTTERS BAR) (RESTRICTION OF WAITING AND PARKING PLACES) (DISABLED PERSONS PARKING PLACES) ORDER 2019

NOTICE IS HEREBY GIVEN that the Hertsmere Borough Council (pursuant to arrangement made with Hertfordshire County Council) proposes to make the above Order under the Road Traffic Regulation Act 1984. The general effect of the Order would be to

- Amend the length of existing permit parking places
- Amend the length of existing disabled bay
- introduce extra permit parking place
- introduce waiting restriction outside 35 Carpenter Way

SCHEDULE

Disabled Person Parking Place At Any Time

Sections of Carpenter Way as set out in the Order and shown on the plan(s) to that Order.

No Waiting 2pm to 3pm Monday to Friday

Sections of Carpenter Way as set out in the Order and shown on the plan(s) to that Order.

Parking Places – Permit Holders Only 2pm to 3pm Monday to Friday

Sections of Carpenter Way as set out in the Order and shown on the plan(s) to that Order.

Eligible addresses for Permits

Carpenter Way (Zone N) - ALL

Allocation of Permits and Charges

Resident Permits – Maximum 2 per property – 1st Permit = £25, 2nd Permit = £40

Visitors Parking Permits - £5 per book of 20 visitors permits

Visitors Annual Permits - £40 per year
