THE HERTSMERE BOROUGH COUNCIL (VARIOUS ROADS INCLUDING GILLS HILL LANE, RADLETT) (RESTRICTION OF WAITING) ORDER 2017 (AMENDMENT NO.1) ORDER 2019

Hertsmere Borough Council (hereinafter referred to as “the Council”) pursuant to arrangements made with Hertfordshire County Council (“the County Council”) under Section 19 of the Local Authorities (Arrangements for Discharge of Functions) (England) Regulations 2012 in exercise of the powers on the said County Council by Sections 1, 2 and 3 of the Road Traffic Regulation Act 1984 (hereinafter referred to as “the Act of 1984”) and Part IV of Schedule 9 of the Act of 1984 and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby make the following Order:

1. This Order may be cited as “The Hertsmere Borough Council (Various Roads including Gills Hill Lane, Radlett) (Restriction of Waiting) Order 2019 (Amendment No. 1) Order 2019” and shall come into operation on XXXXXX2019.
2. The interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
3. The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act of 1984 or by any other enactment.
4. THE HERTSMERE BOROUGH COUNCIL (VARIOUS ROADS INCLUDING GILLS HILL LANE, RADLETT) (RESTRICTION OF WAITING) ORDER 2017 (the “2017 Order”) shall be amended in accordance with Articles 5 and 6 of this Order.
5. The restriction referred to in the Schedule (Line No.4) shall be deleted from the Schedule of the “2017 Order”.
6. The restriction referred to in Schedule 2 to this Order shall be added to the Schedule of the “2017 Order”.
7. The restriction referred to in Schedule 3 to this Order shall be added to the Schedule of the “2017 Order”.
