In 2011 residents were consulted on a proposal for a parking scheme in your area, which indicated that some roads were experiencing parking problems. Since then, the council has had to review how it considers such proposals because of the very large volume of requests it receives and the resource implications of administering and enforcing new and extended Controlled Parking Zones (CPZ). A new parking management strategy document has now been formulated to guide officers and councillors in a manner which better reflects current best practice and balances resources and budgets. The document has been agreed by your councillors.
