# <u>S106 FOI</u>

The number of new s106 agreements which have been entered into by Hertsmere Borough Council and Hertfordshire County Council has declined significantly in recent years, following the introduction of CIL.

Notwithstanding the reduction in s106 agreements, new legal agreements are still signed where Affordable Housing is secured on site or through a commuted sum in lieu of on-site provision. S106 agreements are also used for applications, in the Elstree Way Corridor (for which there is no CIL charge) and contributions can still be sought for site-specific infrastructure on larger sites necessary to make a development acceptable in planning terms.

While generating a response to the information requested, please be aware that the information is based on S106 deeds signed that had financial obligations, not those that had non-financial obligations such as affordable housing or other restrictive covenants.
