Dear Hertsmere Borough Council

I have a FOI request below, but I wanted to let you know that this request is not to catch you out. I am a care leaver and lived in over 100 places. My mission is to help create a system change and we have to do this together. As a Local Authority you are not alone and I will do all I can to help you. At this specific time, I need you to respond to this request ASAP because I need the information.

I've sent this to every Local Authority in England and I will prepare a report, I won't single anyone out, but I will share the findings and importantly offer free advice and guidance to everyone. So please complete the request ASAP. IDEALLY BY 12/02/2020

To make it easier to generate the results I've created a webpage for you to provide the response. Obviously, this is totally at your discretion. But please think of the 10,000 children nationally that need us to come together to help them live better lives.

My request also asks for your lead persons contact details because I want to send the final report and a best practice to help them help our children leaving care.

As a bit of background just in case you are in a 2nd tier Local Authority Area - District and Borough Councils in the Shires. And not sure what the Local Offer for Care Leavers is. You won't be alone. There are 200 lower tier authorities in England that may not have a Local Offer for Care Leavers.

Social Services and Children's services is run by the upper tier, the County Council. And they will know all about this piece of legislation. They will have created a Local Offer, however unless it was created in partnership with the districts and boroughs in the shires it will not include Housing, Leisure and Council Tax to name a few of the services that they are not responsible for. The Act defines what must be considered and this includes public services run by the lower tier authorities. District Councils are specifically named, which means they have to by law create and publish a local offer.

In Nottinghamshire we created the first truly joined up local offer in the country, because all the County Council and the Chief Executives of the Lower Tier Authorities understood their responsibilities but recognised the need and had the foresight to understand that the process of creating the offer would help reach deeper into other parts of the community they serve and to embed into its culture a deep understanding of the plight of the care leaver.. The result has been outstanding. Here is the TV - The Local Offer for Care Leavers on the BBC

In Nottinghamshire we now have a network of 8 Councils all working together for care leavers. We decided to test the network to see how it would respond. It is that network of community that our care leavers need. We made a call for volunteers to take 728 children in care, care leavers and foster parents to Alton Towers for the day. This included EVERY Council in the East Midlands. None of it would have been possible if our councils were not working together.

We campaigned hard to raise awareness accross all the councils and here are the councils showing support
