The authority has the power to approve or reject property addresses submitted by developers or owners, or prescribe its own addressing schemes, under the provision of the following acts:

- Naming of Streets Section 17 Public Health Act 1925
- · Alteration of Street Names Section 18 Public Health Act 1925
- \cdot Numbering and Re-Numbering of Buildings Sections 64 and 65 of the Town Improvement Clauses Act 1847

 Where a street is created as all or part of a new development, all costs for the erection.

Where a street is created as all or part of a new development, all costs for the erection of new street name plates will be paid for by the property developer. Maintenance of street name plates becomes the responsibility of Hertsmere Borough Council only once the developer has left the site and the street has been adopted.

Please note that street name changes will normally only be considered if consistent problems occur for the Emergency Services.
