This Freedom of Information Request is made in light of paragraph 62 of the National Planning Policy Framework (the 'Framework'). Paragraph 62 of the Framework states:

"the size, type and tenure of housing needed for different groups in the community should be assessed and reflected in planning policies (including, but not limited to, those who require affordable housing, families with children, older people, students, people with disabilities, service families, travellers²⁵, people who rent their homes and people wishing to commission or build their own homes²⁶). Our emphasis.

Footnote 26 states:

"26 Under section 1 of the Self Build and Custom Housebuilding Act 2015, local authorities are required to keep a register of those seeking to acquire serviced plots in the area for their own self-build and custom house building. They are also subject to duties under sections 2 and 2A of the Act to have regard to this and to give enough suitable development permissions to meet the identified demand. Self and custom-build properties could provide market or affordable housing." Our emphasis.

The Framework (paragraph 62) is clear in stating that Local Planning Authorities should cater for needs of different groups in the community, including those people 'wishing to commission or build their own homes'. The LPA are required to 'give enough suitable development permissions to meet the identified demand'.

The Appeal Decision APP/G2435/W/18/3214451 Land off Hepworth Road, Woodville DE11 7DW provides clarity on the Councils responsibility concerning self/custom build at paragraphs 22 and 23. The Council should provide information to suggest that there are provisions in place to ensure that permissions which they consider meeting the demands for self/custom build would be developed in a manner that accords with the legal definition of self-build and custom housebuilding in the Self-Build and Custom Housebuilding 2015 (as amended).
