- 1c. No. Our wildflower areas are within are park and open space amenity areas.
- 2. In our parks, this is carried out for the promotion of habitat for insects, butterflies and bees. This is important as animals such as birds and bats feed off the insects and to increase the populations of bees and butterflies. This is an essential component of the food chain. Without pollination people would not enjoy many foods that have become vital in our daily existence. Nearly 75 percent of the food crops worldwide hinge on on these pollinators, consequently, their existence and health affect the food production.
- 3. Historically Hertsmere has focussed on wildflower areas being within parks and amenity open spaces which are larger areas that can benefit from wildflowers.
- 4. We use them on our lower profile shrub beds for control of weed growth. This is necessary in order to ensure all shrubs beds are maintained to a satisfactory standard across the borough. Glyphosate is also used on areas of footpath during edging operations of grass.
