Our Response: As stated above the Council does not hold a general housing stock. However it does hold a small number of houses and flats for use as temporary accommodation. The Council has spent £19,415.00 on replacement domestic boilers during the past five years.

4b) How much of this money covered in part 4) went into installing new gas boilers, and how much went into installing electric heat pumps?

Our Response: All expenditure relates to gas boilers.
