4. How many reports/complaints on fly-tipping did you receive for the above time frame? 1615 reported to EH up to 19/04/2016 and Customer Service reports= 6,060 Complaints = 34 5. What is the cost to the council to rectify fly-tipping offences? This is estimated as £100,000/year as the cost of three full time employees plus vehicle depreciation. The cost of disposal is not included in this estimate and will vary according to the volume of waste collected.
