In issuing an FPN and processing personal data arising from that, the Council is acting under its authority as a law enforcement "competent authority" under Part 3 Data Protection Act 2018 (DPA).

We may not disclose personal details of the recipients of an FPN in an FOI request; these details are exempt. Section 40 (3A) (a) Freedom of Information Act 2000 provides that it is exempt information if disclosure to the public would contravene any of the data protection principles.

The second data protection principle is exercised in this instance. Section 36(1)(b) DPA provides that personal data must not be processed in a manner that is incompatible with the purpose for which it was collected. Your purpose in collecting personal data is to enable you to serve the notice on the correct culprit and keep their personal data in the event that you have to prosecute them.

If a recipient of an FPN wants us to provide them with their own information, this is dealt with by a subject access request under UK GDPR and the DPA.
