# HERTSMERE BOROUGH COUNCIL AIR QUALITY MANAGEMENT AREA REVOCATION ORDER 2024

Hertsmere Borough Council of Civic Offices, Elstree Way, Borehamwood, Herts, WD6 1WA, in exercise of the powers conferred upon it by Section 83 (2) (b) of the Environment Act 1995, hereby makes the following Order.

- 1. This Order revokes as from the date that this Order comes into force:-
  - (1) The Air Quality Management Areas known as **HERTSMERE No.1**, **HERTSMERE No.2**, **HERTSMERE No.3** and **HERTSMERE No.4** within the Hertsmere Borough Council Air Quality Management Order 2003 which came into operation on the 1<sup>st</sup> May 2003 as shown in the Plans attached to this Order.
  - (2) The Air Quality Management Areas known as **HERTSMERE No.5** and **HERTSMERE No.6** within the Hertsmere Borough Council Air Quality Management Order 2004 which came into operation on the 1<sup>st</sup> January 2005 as shown in the Plans attached to this Order.
- 2. The Air Quality Management Areas revoked by this Order are more particulalrly described in the Schedule to this Order.

3. The Order shall come in to force on the 2<sup>nd</sup> day of May 2024.

on the east side of the A5183 High Street Elstree either side of the junction with the A411 identified within the



HERTSMERE No.6 revoke Comprising domestic dwellings within properties


between numbers 133 to 167 High Street on the east side of the High Street opposite the bus station Potters

Bar, identified within the area edged in red on the




Hertsmere Air Quality Management Area No. 1



Hertsmere Air Quality Management Area No. 2




Hertsmere Air Quality Management Area No. 3
