Notes

Main Rivers are designated by Defra on a 'Main River Map'. The Environment Agency has permissive powers to carry out flood defence works, maintenance and operational activities for Main Rivers only. However overall responsibility for maintenance lies with the riparian owner.

An Ordinary Watercourse is a watercourse that does not form part of a Main River. This may include rivers and streams, ditches, drains, cuts, culverts, dikes, sluices, (other than public sewers within the meaning of the Water Industry Act 1991) and passages, through which water flows according to the Land Drainage Act 1991.

This map is intended to provide a strategic overview of fluvial flood risk and should not be used to assess flood risk for individual properties.

The Upper Colne modelling was undertaken by Halcrow in 2010. The Potters Bar Brook modelling was undertaken by Westwood Services in 2018.
