Comments on Elstree Way Corridor Area Action Plan

I set out below comments from Hertswood Academy on the draft Elstree Way Corridor Area Action Plan

Paragraph 4.12 -- the support for a new 1500 m² educational facility on the former Oaklands College site is to be welcomed. On a small point however it should refer to 'further' rather than ' higher' education. The case for retention of this site for education is overwhelming bearing in mind the projected increase of young people aged 16 -- 18 requiring further education in the next 10 years and the current lack of suitable accommodation to meet this demand. This projection comes from Hertfordshire County Council. If there is any doubt that that this educational provision is needed please refer back to further evidence provided in

- a letter from Hertswood School (now Academy) dated 17 November 2011 to the Planning Department in sponse to a planning application to build houses on the site instead; the application was subsequently withdrawn
- a letter from Hertswood Academy to the Leader of the Council on 9 December 2012 about this and other issues

Paragraph 5.7 -- the proposal to remove the underpass under Elstree Way should be accompanied by a commitment to re provide an alternative, safe way for people to cross this busy road. The need for a safe crossing spot remains as Hertswood Academy students from the south of Borehamwood need to get across the road at this point when they come to and from school. It is for highway experts to determine what would be the best alternative but it needs to be at least as safe as the current subway bearing in mind that there are now more students crossing the road and cars using it than when the subway was first built. This commitment should also be to provide the alternative route at the same time as removing the underpass

aragraphs 4.1 and 6.24 -- the proposal to earmark the Civic Centre car park for residential development at some stage in the future requires further justification. It is stated in paragraph 6.24 that such development is long way off but is not clear about whether this might be 2, 5, 10 or 20 years away. This requires further clarity. Paragraph 6.24 also draws attention to the importance of the car park for users of the surrounding community facilities and this is a very busy area with cars/coaches coming and going on a regular basis. Unless there is a reduction in the use of the community facilities and the accompanying traffic, sharing the site for car parking and residential development seems difficult to justify. Including it in the plan now without proper justification will give prospective developers encouragement in the knowledge that the Planning Committee will have to have regard to what the Plan says in considering planning applications.

In considering this matter Hertswood Academy is very concerned about what the effects of developing the car park would have on the Ark Theatre. The public entrance is through the car park and although efforts had been made by HBC and the Academy to improve visibility and this access route, it remains a problem. It is very difficult to see how this visibility and access would be improved through development of the car park and we could be storing up to difficulties for residents living alongside regular streams of people going to and from the theatre up to 11pm each night. Any reduction in the number of people using the theatre would reduce its viability and make it difficult for HBC and the Academy to continue operating as a community theatre.

#### Elstree Corridor Way Action Plan: Public Consultation

Thank you for providing Elstree and Borehamwood Town Council with the opportunity of commenting on the above consultation. The documentation was considered initially by the Environment and Planning Committee at its meeting on 17 January 2013, with the following outcome (Minute 67):

" 67. ELSTREE WAY CORRIDOR AREA ACTION PLAN - PUBLIC CONSULTATION

#### It was AGREED that:

- (i) comments be submitted by committee Members to the Town Clerk by 1 February 2013 for compilation into a consolidated response on the Elstree Way Corridor Action Plan Public Consultation (for final submission prior to the 18th February 2013 deadline); and
- (ii) in addition to responses received (or in their absence) the general comment be submitted that:
- The Council was broadly supportive of the aims and intentions of the Action Plan insofar as it sought to improve the area; and
- the Council was somewhat concerned about the scale and density of proposed development with associated implications for the local infrastructure (especially GP surgeries and Schools)".

In addition, the following comments have been submitted:

- Overall the document was felt to be well presented and user friendly.
- Members repeated concerns over the available infrastructure to support c.800 new homes and, therefore, c.2,000 people. It was suggested that plans for a primary school and surgery (or comprehensive health centre) should be included to cater for the larger population.

- Some Members proposed that CCTV should be a necessary requirement to receive planning permission for all Open Spaces and Play Areas (to help prevent anti-social behaviour; (page 22 6.39).
- Concerns were expressed about the three signalised junctions, especially during peak periods which could cause traffic congestion at one of the principal entrance/exit points in Borehamwood. Reducing traffic to one lane in Shenley Road was similarly seen as problematic in causing bottlenecks (page 13 item 5.2b).
- It was suggested that disabled access to larger residential developments should be made compulsory (page 6 Development Strategy a).
- Safe cycling routes throughout the Town and an improvement of Maxwell Park were encouraged to enhance the area.
- Members recognised the positive work being undertaken for the Community by the availability of public spaces and facilities. Against this background it was hoped that any outcomes of the scheme would not reduce, but ideally increase, such availability.
- It was suggested that Borehamwood lacked family homes and a greater emphasis on larger homes and flats was proposed together with social homes with priority given to local families.
- Some Members proposed the introduction of CPZ to ensure that there was sufficient parking for residents. It was also suggested that this measure would encourage visitors to park at the Town Centre car parks rather than in the development. CPZ could also assist with plans for dual resident/worker parking.

The Town Council looks forward to being kept informed of developments and would formally request to be consulted again, especially if any proposals were made to relocate the Borehamwood War Memorial to an alternative site.

I hope that this is helpful.
