ROAD TRAFFIC REGULATION ACT 1984

THE HERTSMERE BOROUGH COUNCIL (BUSHEY HIGH ROAD ,ST PETERS CLOSE, THE RUTTS, CALIFORNIA LANE, HOWTON PLACE, WARREN ROAD AND BUSHEY HIGH ROAD (SERVICE ROAD), BUSHEY) (RESTRICTION OF WAITING) ORDER 201*

Hertsmere Borough Council (hereinafter referred to as "the Council") pursuant to arrangements made with Hertfordshire County Council ("the County Council") under Section 19 of the Local Government Act 2000 and the Local Government (Arrangements for Discharge of Functions) (England) Regulations 2000 in exercise of the powers on the said County Council by Sections 1, 2, 3, 4, to the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act of 1984"), Part IV of Schedule 9 of the Act of 1984 and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby make the following Order:

- This Order may be cited as "The Hertsmere Borough Council (Bushey High Road, St Peters Close, The Rutts, California Lane, Howton Place and Warren Road Bushey) (Restriction of waiting) Order 201*" and shall come into operation on xxxxxx201*
- 2. Save as provided in Articles 3, 4 and 5(1) of this Order no person shall cause or permit any vehicle to wait at any time in those lengths of Bushey High Road, St Peters Close, The Rutts, California Lane, Howton Place and Warren Road Bushey as specified in the Schedule to this Order.
- 3. (1) Nothing in Article 2 of this Order applies to the lengths of road restricted by those Articles (which said lengths of road are referred to in this Article as "the restricted area") in relation to:
 - (a) A vehicle being used for fire and rescue, ambulance or police purposes.
 - (b) Anything done with the permission of or at the direction of a police constable in uniform or with the permission of a Civil Enforcement Officer appointed by Hertsmere Borough Council and as defined by the Traffic Management Act 2004.
 - (c) A vehicle which is prevented from proceeding by circumstances beyond the drivers control or which has stopped in order to avoid injury or damage to persons or property or when required to do so by law;
 - (d) A vehicle which is stationary in order that it may be used for one or more of the purposes specified in sub-Article (2) of this Article and which cannot reasonably be used for such a purpose without stopping in the restricted area;

(e) A marked vehicle which, whilst used by a universal service provider in the course of the provision of a universal postal service, is stationary only for so long as may reasonably be necessary for postal packets to be delivered or collected;

In this Article;

The expression "universal service provider", "provision of a universal postal service" and "postal packet" shall bear the same meanings as in the Postal Services Act 2000.

- (2) The "purposes" referred to in sub-Article (1)(d) of this Article are:
 - (a) Any operation involving building, demolition or excavation;
 - (b) The removal of any obstruction to traffic;
 - (c) The maintenance, improvement or reconstruction of a road;
 - (d) Constructing, improving, maintaining or cleaning of any street furniture; or
 - (e) The laying, erection, alteration, repair or cleaning of any sewer or of any main pipe or apparatus for the supply of gas, water or electricity, or of any telecommunications apparatus kept or installed for the purposes of a telecommunications code system or of any other telecommunications apparatus lawfully kept installed in any position.
- 4. Nothing in Article 2 of this Order applies to the lengths of road restricted by those Articles (which said lengths of road are referred in this Article as "the restricted area") so as to render it unlawful to cause or permit any vehicle to wait only for so long as may reasonably be necessary -
 - (a) to enable goods to be loaded on or unloaded from the vehicle from or to premises adjacent to the restricted area; or
 - (b) to enable a passenger to board or alight and to load and unload any luggage.
- 5. (1) Nothing in Article 2 of this Order shall render it unlawful to cause or permit a disabled person's vehicle which displays in the relevant position a disabled person's badge, and a parking disc, to wait at any time in the lengths of road specified in the Schedule of this Order for a period not exceeding 3 hours (not being a period separated by an interval of less than 1 hour from a previous period of waiting by the same vehicle in the same length of road).

(2)In this Article -

"disabled person's vehicle" has the same meaning as in Section 142(1) of the Act of 1984;

"disabled person" means a disabled person of a description prescribed by Regulation 4 of the Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000 SI 682; "disabled persons badge", "Blue Badge" have the same meaning as given in the Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000 SI 682;

"driver" means the person driving or having control or charge of the vehicle at any given time and in particular in relation to the vehicle.

"parking disc" has the same meaning as given in Regulation 8(5) of The Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England) Regulations 2000;

"Penalty Charge" shall have the meaning as a charge set by the Council in accordance with The Civil Enforcement of Parking Contraventions(Guidelines on Levels and Charges)(England) Order 2007 and the provisions of part 6 and Schedule 9 of the Traffic Management Act 2004 and

"Relevant position" has the same meaning as given in Regulation 4 of The Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England) Regulations 2000.

"vehicle" means passenger motor vehicle or motor cycle not larger than 2.30 metres in height and 5.25 metres.

- 6. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament:
- 7. Where a motor vehicle is parked in contravention of any of the Articles to this Order the driver of any such vehicle shall be issued with a penalty charge notice.
- 8. The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act of 1984 or by any other enactment.
- 9. The provisions of the following Order is hereby revoked but only in so far as they are affected by the restrictions imposed by this Order;

Bushey High Road (East side)	2. From a point approximately 1metres south east of the south east boundary of property number 6/4 south eastwards for a distance of approximately 22metres.
Bushey High Road (East side)	3.From a point approximately 19metres south east of the south east boundary of St Peters Parish Hall south eastwards for a distance of approximately19metres.
Bushey High Road (East side)	4. From a point in line with the common boundary between property numbers 18 and 20 Bushey High Road south eastwards for a distance of approximately 4metres.
Bushey High Road (East side)	5.From a point approximately 3metres south east of a point on the line of the common boundary between property numbers 20 and 22 Bushey High Road south eastwards for a distance of approximately 7metres.
Bushey High Road (East side)	6.From a point approximately 1metre south east of a point on the line of the common boundary between property numbers 24 and 26 Bushey High Road south eastwards for a distance of approximately 7metres.
Bushey High Road (East side)	7.From a point approximately 1metres south east of a point on the line of the common boundary between property numbers 32-36 and 38-40 Bushey High Road south eastwards for a distance of approximately 12metres.
Bushey High Road (East side)	8. From a point approximately 24 metres south east of the southeastern boundary of 38-40 Bushey High Road south eastwards for a distance of approximately 16 metres.
Bushey High Road (East side)	9. From a point approximately 5metres south east of a point on the line of the common boundary between property numbers 60 and 62/64 Bushey High Road, south eastwards for a distance of approximately 8metres.
Bushey High Road (East side)	10.From a point approximately 7metres south east of the south east boundary of property number 116 Bushey High Road, south-eastwards for a distance of approximately 12metres.
Bushey High Road (East side)	11.From a point approximately 12metres south east of a point on the line of the common boundary between property numbers 120 and 122 Bushey High Road, south eastwards for a distance of approximately 10metres.
Bushey High Road	12.From a point approximately 9metres south east of the south east boundary of property number 124 Bushey High Road south eastwards for

Bushey High Road (West side)	13. From a point in line with the south east boundary of Bushey Heath Methodist Church, north westwards for a distance of approximately 70metres
Bushey High Road (West side)	14.From a point approximately 1metres north west of a point on the line of the common boundary between property numbers 51 and 53 Bushey High Road north westwards for a distance of approximately 6metres.
Bushey High Road (West side)	15. From a point opproximately 9metres north west of a point on the line of the common boundary between 21 Bushey High Road and California court north westwards for a distance of approximetly 38metres.
Bushey High Road (West side)	16. From a point approximately 4metres north west of the south east boundary of property number 1 Warren Road , north westwards for a distance of approximately 54metres
Bushey High Road (West side)	17. From a point approximately 1metres north west of the south east boundary of property number 19 Bushey High Road north westwards for a distance of approximately 6metres
Bushey High Road (West side)	18. From a point approximately 2metres south east of a point on the line of the common boundary between property numbers 11 and 13 Bushey High Road, south eastwards for a distance of approximately 36m
Bushey High Road (West side)	19.From a point approximately 10metres north west of a point on the line of the common boundary between property numbers 11 and 13 Bushey High Road, north westwards for a distance of approximately 6metres

ST PETERS CLOSE

St Peters Close West side	1. From a point approximately 7metres south west of a point on the line of the common boundary between property numbers 8/10 and 12/14 St Peters Close to the south west kerbline of St Peters Close junction with Bushey High Road.
St Peters Close East side	2. From a point opposite 7metres south west of a point on the line of the common boundary between property numbers 8/10 and 12/14 St Peters Close to the north east kerbline of St Peters Close junction with Bushey High Road

THE RUTTS

The Rutts West side	1. From a point approximately 15metres south of the north east boundary of property number 1-7 Windmill Court to the south east kerbline of The Rutts junction with Bushey High Road.
The Rutts East side	2. From a point approximately 13metres opposite the north east boundary of property number 1-7 Windmill court to the north west kerbline of The Rutts junction with Bushey High Road.

CALIFORNIA LANE

California Lane West side	1. From a point approximately 23metres north east of the south west boundary of California court to the north east kerbine of California Lane junction with Bushey High Road
California Lane East side	2. From a point approximately 22metres opposite the south west boundary of California court to the south west kerbline of California lane junction with Bushey High Road.

HOWTON PLACE

Howton Place West side	1. From a point approximately 25metres opposite the south west boundary of property number 1 Howton Place to the north east kerb line of Howton place junction with Bushey High Road.
Howton Place East side	2. From a point approximately 24.6metres northeast of the southwestern boundary of property number 1 Howton Place to the south western kerbline of Howton Place junction with Bushey High Road.

WARREN ROAD

Warren Road West side	1. From a point approximately 22metres opposite a point on the line of the common boundary between 1 and 3 Waren Road to the north eastern kerbline of Warren Road junction with Bushey High Road
Warren Road East side	2. From a point approximately 26metres northeast of a point on the line of the common boundary between 1 and 3 Waren Road to the north eastern kerbline of Warren Road junction with Bushey High Road

BUSHEY HIGH ROAD (SERVICE ROAD)

Service Road West Side	1. From a point approximately 3metres north west of the north west boundary of property number 47 Bushey High Road (Service Road) north westwards for a distance of approximately 23metres
Service Road West Side	2. From a point approximately 28metres north west of the north west boundary of property number 47 Bushey High Road (Service Road) and continues south westwards round the central reservation for a distance of approximately 50m.
Service Road East Side	3. From the north west kerbline of Bushey High Road (Service Road) to a point approximately 8metres north west of a point on the line of the common boundary between property numbers 33 and 35 Bushey High Road (Service Road).
