HERTSMERE BOROUGH COUNCIL
(HIGH STREET, BUSHEY) (RESTRICTION OF WAITING) ORDER 2020
(AMENDMENT NO.1) ORDER 2026

Hertsmere Borough Council (hereinafter referred to as “the council”) pursuant to arrangements made with Hertfordshire County Council (“The County Council”) under Section 19 of the Local Authorities (Arrangements for the Discharge of Functions) (England) Regulations 2012 in exercise of the powers on the said County Council by sections 1, 2 and 3 of the Road Traffic Regulation Act 1984 (hereinafter referred to as “the Act of 1984”) and Part IV of Schedule 9 of the Act of 1984 and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby make the following Order:

1. This order shall come into operation on XXXXXXXXX 2026 and may be cited as “The Hertsmere Borough Council (High Street, Bushey) (Restriction of Waiting) Order 2020 (Amendment No.1) Order 2026” hereinafter referred to as “this Order”.
2. “Map based schedule” means a collection of maps attached to this Order and listed in Schedule 1 which depict the parking places or waiting restrictions designated, authorised or imposed, as the case may be, by this Order and, where appropriate, certain of their governing provisions:

Provided that the Council does not accept responsibility for any inaccuracies contained in the Ordnance Survey data relied upon to create the map based schedule and where a parking place or length of waiting restrictions is depicted on the map based schedule, that parking place or length of waiting restrictions will continue to apply irrespective of any subsequent changes that have been made to the underlying Ordnance Survey data;
3. The provision of The Hertsmere Borough Council (High Street, Bushey) (Restriction of Waiting) Order 2020 shall be amended in the manner and to the extent specified in the Schedule to this Order.
4. The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any other regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.
5. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
