

HERTSMERE BOROUGH COUNCIL AIR QUALITY ACTION PROGRESS REPORT

Introduction

In the 2003 Action Plan the section “Timescales” was not included in the report. This report has added this missing section combined with the Comments section. Since 2003 Action Plan progress reporting has changed due to new technology and ideas to help with Air Quality, this progress report on the Action Plan hopes to bring Hertsmerre Borough Council Air Quality actions up to date. To help with this some of the old actions have been combined and wording changed. These are as follows:

No 1-action plan has had the wording changed from “health information” to “exposure of sensitive groups”. Information still hard to obtain as PCT cannot divulge patient information. Information (stats) could be drawn from census data?

Action 6 has been combined with Action 3.

Action 10 has been combined with Action 9.

Action 16 has been combined with Action 17.

Action 20 is a new action.

The National Air Quality Strategy (NAQS), which was introduced in 1997 revised in 2000 and revised again in 2007, not only set air quality standards and objectives for local authorities to work towards, it also gave us responsibility for periodically reviewing local air quality. Following a report in 2002 Hertsmerre Borough Council declared 14 areas as Air Quality Management Area’s (AQMA) areas that would not meet the standards set in the Air Quality Strategy for nitrogen dioxide. In a further review and assessment the Council revoked 10 of the 14 AQMA’s. All these areas being motorway pollutant related.

In 2003, the Council produced its Air Quality Action Plan. This identified a number of specific actions, which when implemented, should help to improve air quality within the Borough and therefore help us work towards achieving the air quality objectives set out in the NAQS.

In 2004 two further, non-motorway, AQMA's were declared. Actions for these two AQMA's have been included in Hertfordshire County Council Local Transport Plan. It is now time to reproduce a progress report that gives us an indication of how far we have got with the 19 actions set out in the original Plan.

Progress with the plans has been slow with a majority of the plans. Slow progress is due to four out of six of our AQMA's being beside the motorway. Some of the actions have been combined as they were very similar and newer actions and ideas are around that can be implemented easily. Environmental Health works closely with other bodies to implement the plan these include Hertfordshire County Council, Highways Agency, Hertfordshire Highways, Planning Department. Some actions are not the sole responsibility of Environmental Health or Hertsmeire Borough Council.
