Permit Parking Zone R (Extension)

We are writing to inform you that the representations and comments received during the formal consultation regarding the proposal to introduce permit parking in Christchurch Crescent and Loom Place, Radlett, have been included in a report reviewed by the council's porfolio holder for street scene.

NOTICE IS HEREBY GIVEN that the Hertsmere Borough Council (pursuant to arrangement made with Hertfordshire County Council) has made the above Orders under the Road Traffic Regulation Act 1984. The Orders will come into effect on Monday 9th June 2025.

The general effect of the Order would be to introduce waiting restrictions and residents parking places in Christchurch Crescent and Loom Place.

The proposal is necessary to increase the available provision of residents parking places, reduce instances of inappropriate and inconsiderate parking, improve visibility at road junctions and property entrances, improve access to adjacent properties, and improve road safety.
