

**HERTSMERE BOROUGH COUNCIL  
(BUSHEY VILLAGE) (DISABLED BAYS, RESTRICTION OF WAITING, RESIDENTS PARKING  
AND SHARED USE PARKING PLACES) ORDER 2026**

NOTICE IS HEREBY GIVEN that the Hertsmere Borough Council, pursuant to arrangement made with Hertfordshire County Council proposes to make the above-mentioned Order under the Road Traffic Regulation Act 1984.

The general effect of the Order would be to introduce waiting restrictions, residents parking places, disabled parking places and shared use parking places to improve road safety, reduce instances of inappropriate or inconsiderate parking and increase the available provision of resident parking places.
