		Not enough data has been provided by you to evidence that all residents in the zone will have access to a parking bay so there is no guarantee it will be an improvement. Resident participation numbers in the last survey could not have provided you with an accurate number of resident cars requiring parking in the road. The proposal to introduce double yellow lines along Herkomer on one side from Falconer Road to Bournehall will reduce available parking. That side always has cars parked along it and as the proposal is one zone incorporating all the village roads, its likely to displace cars onto Falconer Road and others. The question being if this scheme is introduced, can you guarantee that all residents will get a parking space, which they will then be paying for?
		The parking issues on Falconer Road came about because the council introduced parking charges in the village and Kemp Place. These can be issued and managed via the smartphone apps. -Consult with the Schools (Academy & Falconer School) regarding their staff's parking arrangements, ensuring that they do not use residential roads. Maximise residential parking capacity -Our road could (notwithstanding the need for Highways' assessment in terms of sightlines and safety) accommodate more spaces. -There are circa 82 metres (in aggregate length of scrappy grass & grasscrete verge). -Based on the average UK parking space being 4.8m in length, that equates to 17 additional car spaces. A CPZ may seem to be the easier solution, as the others require more engagement with the Schools, Local Businesses and Community/Religious Groups. My suggestion would enhance the lives of residents, whilst continuing to "tread lightly" on them. However, the additional benefits would be: -Maximising the use a publicly owned asset (the Car Park). -Enabling and enhancing the prosperity of the local High Street by encouraging visitors. -Less additional administration for the Council and Residents. -Residents (and their visitors) being unfettered coming and going from their homes. This includes "79" (Nightingale Corner) to 89 Herkomer Road. Most of the time people park on the other side of the road, outside of Revelry Cottages. This is where the proposed parking bay will be which we support. On narrow roads, people should always be encouraged to park on one side of the road only and not to double park. Unfortunately our part of Herkomer Road is an overspill for Park Road and always will be. Even with the proposed changes to
		parking, we don't think this will be enough to discourage drivers from double parking on our very busy and narrow road. This is when it gets very dangerous. Double parking causes difficulty in crossing the road and reduces visibility for accessing driveways. Larger traffic such as lorries and emergency vehicles are unlikely to get through when people double park. It's normally after 18:30 that double parking happens (when there are no spaces left in Park Road), so the proposed single yellow lines will not be enough. We have had our wall damaged twice in the past due to vehicle parking outside of our house. People park over the pavement which prevents pedestrians from passing especially if they have prams or are wheelchairs users. We have seen on CCTV that the wall has been damaged by pedestrians being forced to push up against it to get passed. When people park outside of our house they also block the pedestrian access in our wall which means we cannot use it.
		It is good to see the proposed double yellow lines on both sides of the street on the bend near Bournehall Road. This is an especially dangerous part of the road and warrants double yellow lines on both sides of the road.
